The stands may be set up from Friday, 29 May 2026, from 06:00am. Should you wish to arrive before the 29th, please contact Pierre Loots or Johan Breytenbach – Thaba Fire & Rescue to make the necessary arrangements.

An additional fee of R150.00 per person per night will be charged for Fire Festival accommodation, which includes security (guards) and overnight cost arrangements. Each stand will be allocated a number in the order in which applications are received. No changes to stands numbers will be permitted unless arranged in advance. Please take note that no security guards will be available on 28 May 2026.


